ONDE is the centralised system for filing the following information with the Autorité des Marchés Financiers (AMF):

- the regulated information defined in Article 221-1 of the AMF General Regulation, such as the annual financial report, report on corporate governance and internal control, inside information;
- information published on the same terms as regulated information but not falling within its definition such as, for example, news releases published during a takeover bid period;
- the final terms of issue of debt securities;
- transactions in the company's securities by the officers, directors and persons mentioned in Article L. 621-18-2 of the Monetary and Financial Code;
- shareholding threshold crossing declarations;
- significant net short positions in shares admitted to trading on a French trading venue (Nyse Euronext Paris and Alternext Paris) pursuant to Article 5 of European regulation (EU) n° 236/2012;

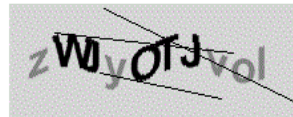
