

News and Updates

- Total value of shares bought by international investors in the first ten months of 2019 amounted to JD 440.2 million, representing 32.0% of the overall trading value, while the value of shares sold by international investors amounted to JD 334.2 million during the same period. Accordingly, the net of international investments increased by JD 106.1 million in the first ten months of 2019, compared to an increase of JD 26.9 million recorded in the same period of 2018. *ASE*
- Real estate trading in Jordan in the first ten months of 2019 amounted to JD 3,581 million, representing a drop of 19% compared to the same period of 2018. *Department of land and Survey*
- Number of apartments sold during the first ten months of 2019 dropped to 25.6 thousand apartments, compared to 28.5 thousand apartments sold during the first ten months of 2018. *Department of land and Survey*
