

## News and Updates

☼ Total value of shares bought by international investors in the first nine months of 2019 amounted to JD 266.3 million, representing 24.0% of the overall trading value, while the value of shares sold by international investors amounted to JD 313.6 million during the same period. Accordingly, the net of international investments decreased by JD 47.3 million in the first nine months of 2019, compared to an increase of JD 33.2 million recorded in the same period of 2018. *ASE*

☼ Total deposits held at licensed banks in Jordan amounted to JD 34.696 billion at the end of August 2019, compared to JD 33.848 billion recorded at the end of 2018. Credit facilities extended by licensed banks amounted to JD 27.031 billion at the end of August 2019, compared to JD 26.112 billion recorded end of 2018. *Central Bank of Jordan*

☼ Jordan's GDP grew by 1.8% in the second quarter of 2019 compared to the second quarter of 2018. *Department of Statistics*
