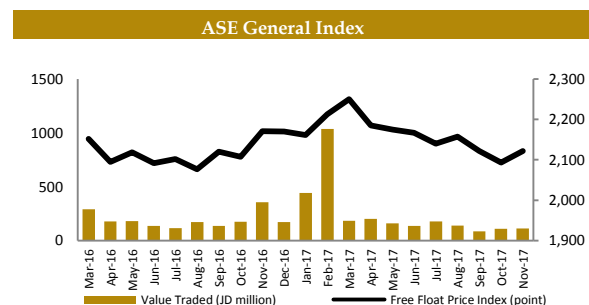

- The Central Bank of Jordan raised the interest rate on its various monetary policy instruments by 25 basis points. The Central Bank of Jordan's main interest rate increased to 4%.
- Figures released by the Central Bank of Jordan showed that Jordan's income from tourism increased by 12.8% during the first eleven months of 2017 compared to the same period of 2016 to reach USD 4.2 billion.
- According to the Department of Statistics, inflation rate in Jordan increased by 3.3% during the first eleven months of 2017 compared to an increase of 0.9% recorded during the same period of 2016.
