- According to the Department of Statistics, Jordan's consumption of fuel reached JOD 1.06 billion during the first six months of 2017, compared to JOD 1.8 billion recorded during the same period of 2016.
- Government of Jordan signed a EUR 200 million agreement with the European Union to receive macro-financial assistance.
- Jordan will resume exports through its main border crossing with • Iraq on Monday October 2nd for the first time since 2015.
- Government of Jordan raised the prices of fuel and oil derivative • by up to 5%, with exception of household gas, effective October 1^{st} .
- The Greater Amman Municipality (GAM) announced a JOD 25 ٠ million tender of two phases of the Rapid Bus project.
