# Monthly Statistical Issue

## MONTHLY REVIEW

On the last trading session of October 2022 the General Index reached 76,61 points, representing a relative increase of 3,93% from the previous month. The value of shares traded exhibited an increase of 188,95% compared to the previous month.

It is worth mentioning however, that the highest level that the General Index reached for the month was 76,61 points. The other Market Indices reached the following levels: Main Market reached 50,34, Alternative Market 986,99, Investment Companies 826,14 points. On a sectoral level, the Hotels Index reached 884,89 points. The FTSE/CySE20 reached 46,01 points. The market capitalisation of shares (shares) reached € 2,15 billion. According to this month's results, the Main Market accounted for 36,70% of the total market capitalisation, the Alternative Market 21,72%, the Surveillance Market 1,40% and the Bond Market 40,18%. Moreover, the total market capitalisation including the Bond Market reached € 3,60 billion compared to € 3,52 billion the previous month, registering an increase of 2,22%.

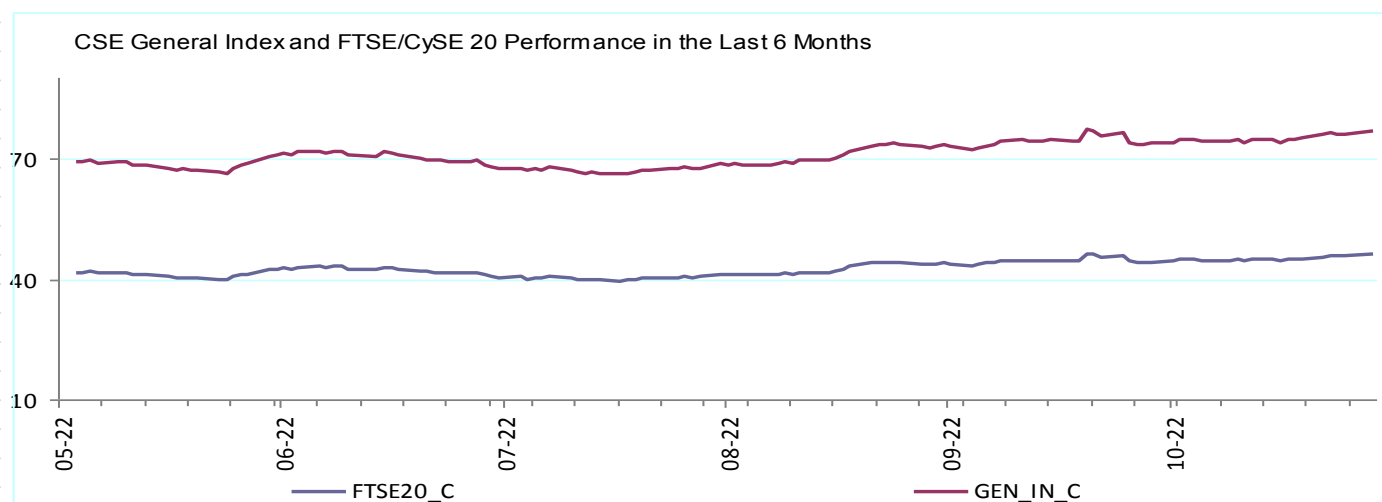
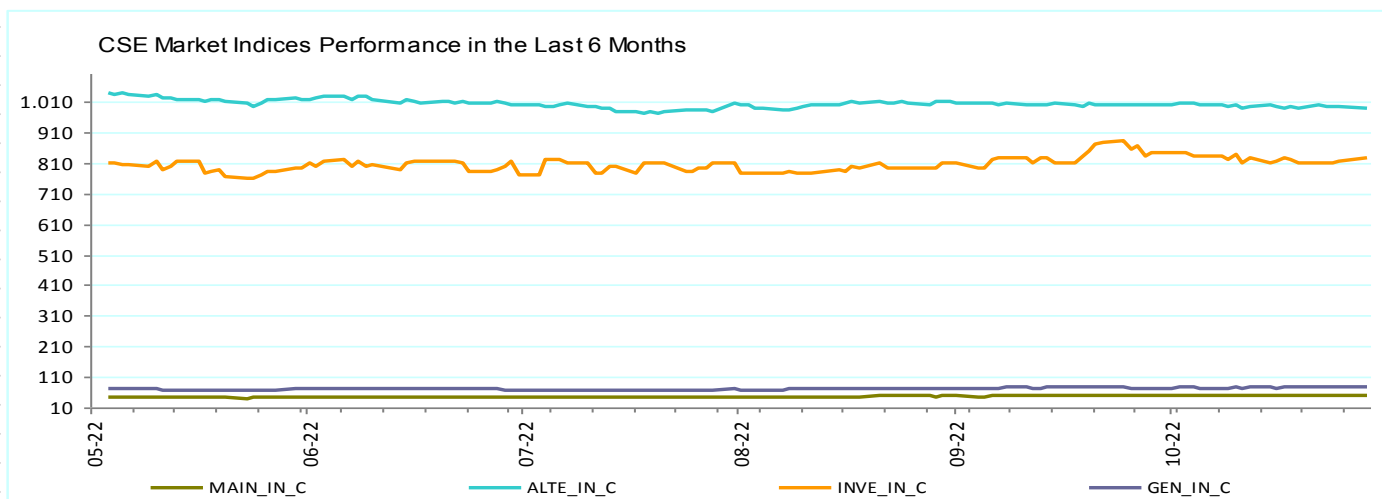
The total value of transactions during the month in review reached € 14,24 million, with an average of €0,71 million per trading session. The Financials sector contributed 95,55% to the total value traded which was the highest among all other sectors. Investors primarily focused their interest on the shares of "Bank of Cyprus Holdings Plc" and also on shares of "The Cyprus Cement Public Company Ltd" with 93,80% and 0,71% of the total value respectively.

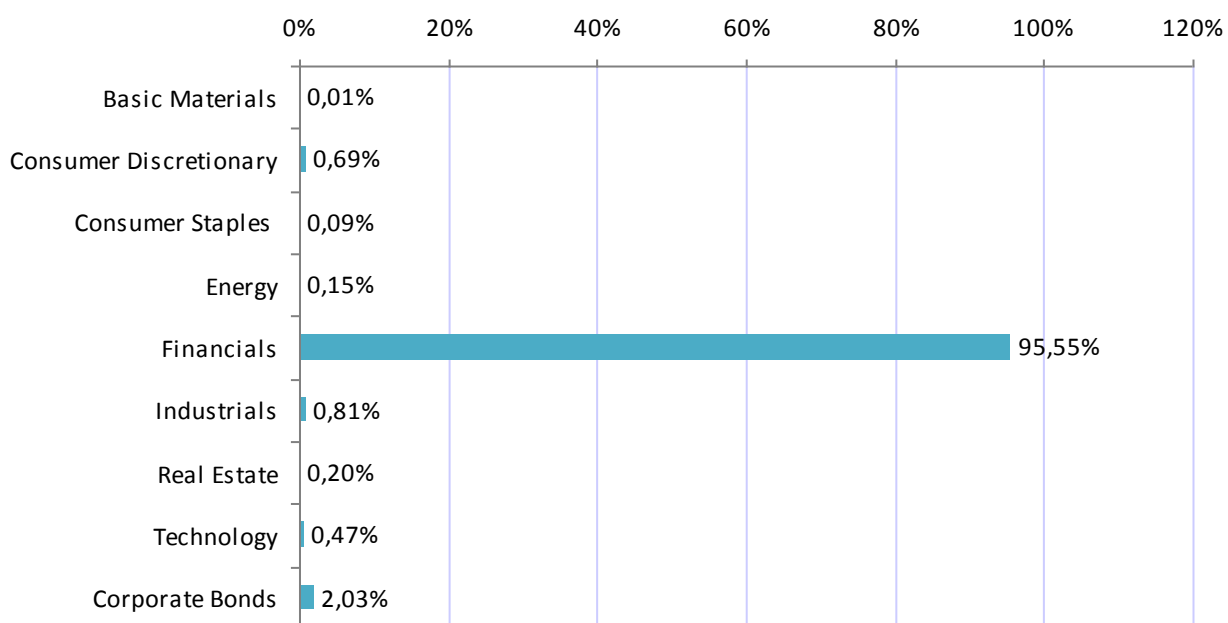

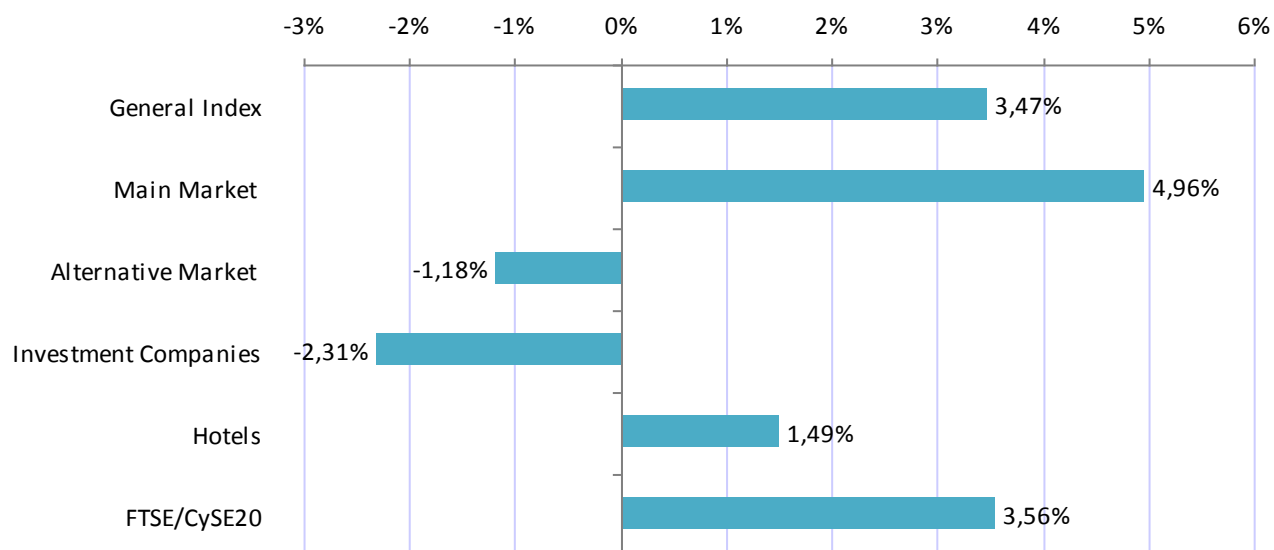

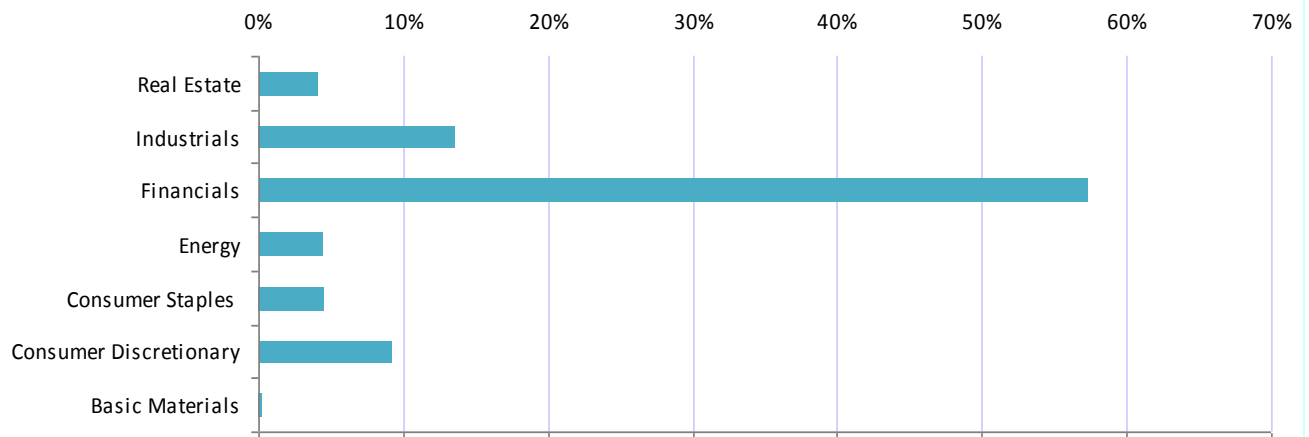

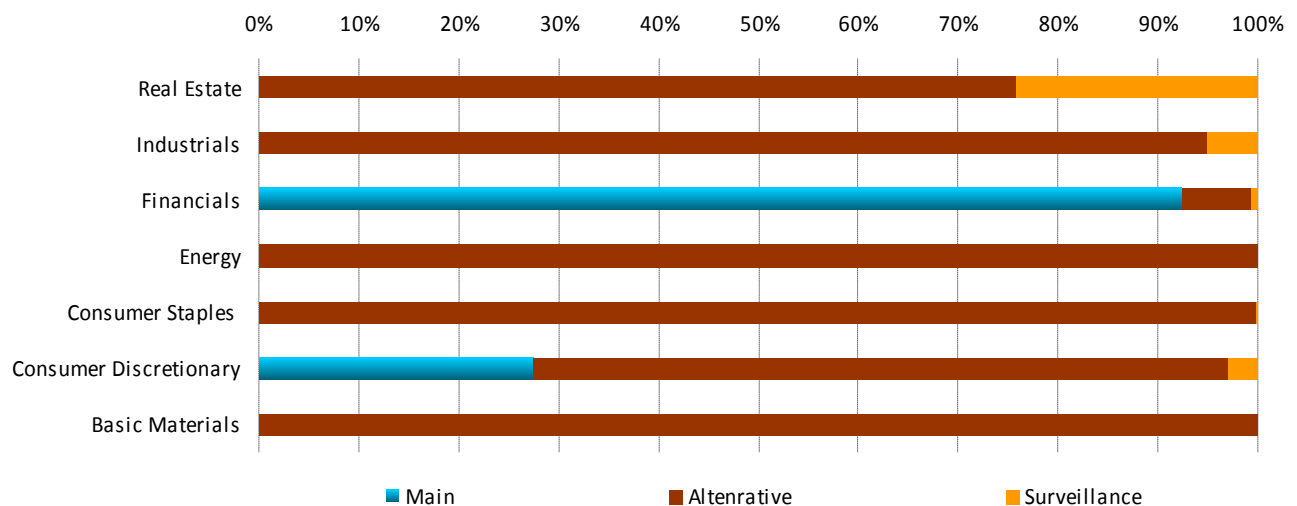

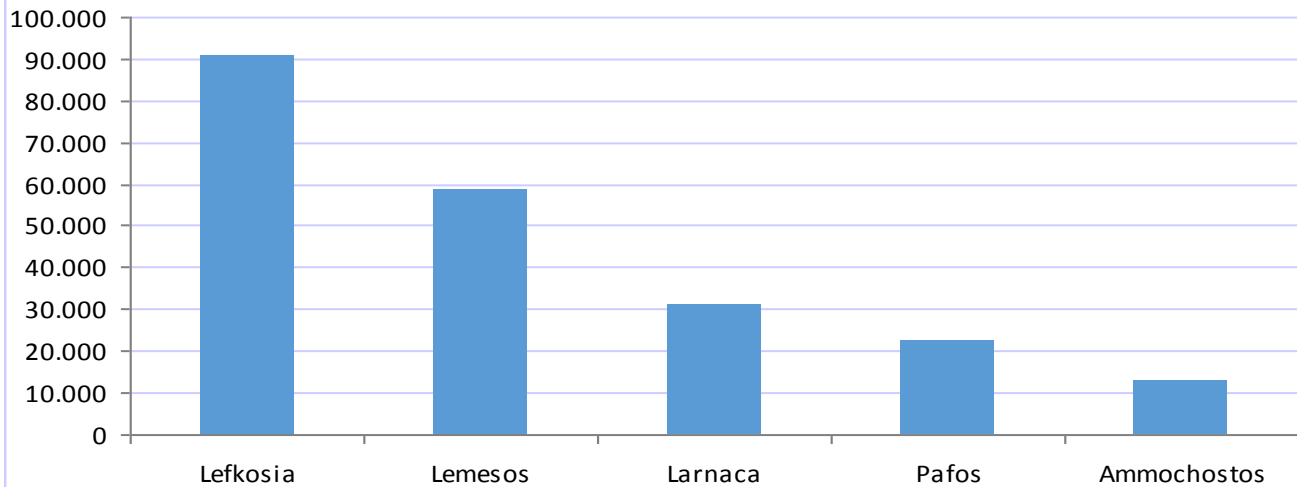

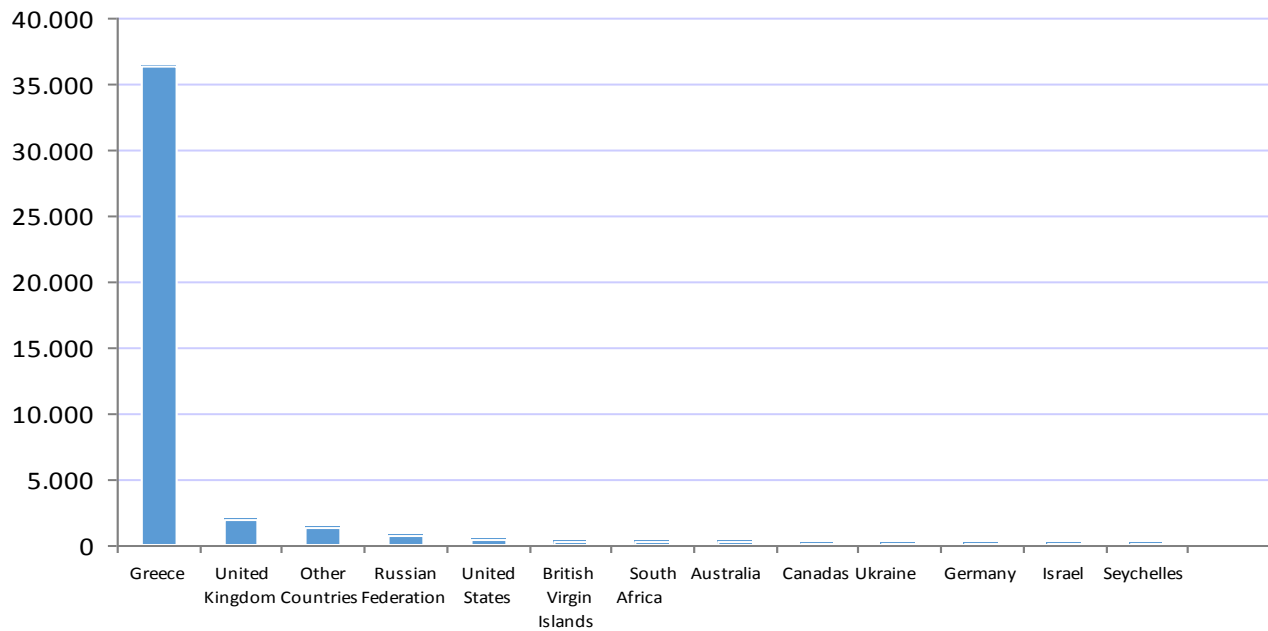
