STOCK MARKET ACTIVITY FOR MARCH 2017

On the last trading session of March 2017 the General Index reached 68,08 points, representing a relative increase of 2,31% from the previous month. The value of shares traded exhibited an increase of 21,91% compared to the previous month.

It is worth mentioning however, that the highest level that the General Index reached for the month was 68,08 points. The other Market Indices reached the following levels: Main Market reached 45,80, Alternative Market 781,42, Investment Companies 817,94 points. On a sectoral level, the Hotels Index reached 560,27 points. The FTSE/CySE20 reached 40,53 points and finally the FTSE Med reached 4.638,23 points.

The market capitalisation of shares (shares) reached € 2,41 billion. According to this month's results, the Main Market accounted for 38,55% of the total market capitalisation, the Alternative Market 19,15%, the Surveillance Market 0,31% and the Bond Market 41,99%. Moreover, the total market capitalisation including the Bond Market reached € 4,15 billion compared to € 4,20 billion the previous month, registering a decrease of 1,14%.

The total value of transactions during the month in review reached € 4,40 million, with an average of €0,19 million per trading session. The Financials sector contributed 85,52% to the total value traded which was the highest among all other sectors. Investors primarily focused their interest on the shares of "Bank of Cyprus Holdings Plc" and also on shares of "Hellenic Bank Public Company Ltd" with 68,97% and 7,92% of the total value respectively.



Listing of Government Titles

13-Week Treasury Bills. On 1st March 2017, the Cyprus Stock Exchange announced that it has accepted the listing on the CSE of 100.000 13-Week Treasury Bills, 3rd Issue, Series 2017 (3/3/2017 − 2/6/2017) of a nominal value of €1000 each, of a total value of €100.000.000, which have resulted from an auction carried out on 28 February 2017. Their date of issue was 3 March 2017. The code of the above titles to be listed on the Bonds Market is ΓΔ13Γ17/ TB13C17. The Bills did not bear an interest rate. Their trading started on Friday, 3 March 2017.

Activation of a New Member on the CSE Markets

EGR Broking Ltd. On 1st March 2017, the Cyprus Stock Exchange (CSE) announced that "EGR Broking Ltd" has become a Remote Member of the CSE with a possibility of full activation as of Thursday, 2 March 2017.

Suspension of Trading and Delisting of Government Titles

Government Development Bonds. On 8th March 2017, the Cyprus Stock Exchange announced the suspension of trading of Government Bonds, 3rd Series 2007, Maturity 2017, at 4.50% interest under code KX103A07/ GB103A07 from 22 March 2017 until 24 March 2017 (inclusive), i.e. until the clearing of all transactions in view of the delisting of the titles. The above Government Bonds delisted on 27 March 2017.

Government Development Bonds. On 24th March 2017, the Cyprus Stock Exchange announced the suspension of trading of 5.60% Government Bonds, 1st Series 2002, Maturity 2017, under code KX151A02/ GB151A02 from 5 April 2017 until 7 April 2017 (inclusive), i.e. until the clearing of all transactions in view of the delisting of the titles. The above Government Bonds will be delisted on 10 April 2017.

13-week Treasury Bills. On 31st March 2017, the Cyprus Stock Exchange announced the suspension of trading of the 13-week Treasury Bills 1st Issue Series 2017 (9/1/2017 -7/4/2017), with code $\Gamma\Delta$ 13A17/ TB13A17 from 4 April 2017 until 6 April 2017 (inclusive), i.e. until the clearing of all transactions in view of the delisting of the titles. The above Treasury Bills will be delisted on 7 April 2017.

Removal from the Register of Members

Hellenic Bank (Investments) Ltd. On 15th March 2017, the CSE Council decided, following a request from the Hellenic Bank (Investments) Ltd, to proceed with its removal from the register of members of the Cyprus Stock Exchange with effect from 16 March 2017.

Inadequate compliance with the provisions of the Corporate Governance Code

Agros Development Company "Proodos" Public Ltd and Pierides Holdings Plc. On 29^{th} March 2017, the Cyprus Stock Exchange announced that, as of 30 March 2017, the titles of the issuers Agros Development Company "Proodos" Public Ltd and Pierides Holdings Plc, which are traded on the Alternative Market of the CSE, will appear in the price bulletins with the (Σ) marking, pursuant to provision 2.2.6 (a) of RAA 379/2014, as amended, since the two issuers do not comply with provision B.3.1. of the Corporate Governance Code, which is mandatory for all issuers of the Regulated Market under paragraph 5.2.9 of RAA 379/2014, as amended, and concerns the obligation to publish detailed information on the remuneration of the Directors by name.

The (Σ) marking will be removed from the price bulletins once it is established that the reasons for such marking no longer apply.

Continuation of Suspension of Trading

Sea Star Capital Plc. On 30th March 2017, following its announcement of 31 January 2017 and further to the decision of the Securities and Exchange Commission, the Cyprus Stock Exchange announced the continuation of the suspension of trading of the titles of Sea Star Capital Plc.

The Securities and Exchange Commission, after taking into account the fact that the Cyprus Stock Exchange has no power to suspend the company's titles for a further period if the reasons imposing the continuation of the suspension of trading of its titles continue to exist, has decided, pursuant to the powers conferred by Article 127(2) of the Investment Services and Activities and Regulated Markets Law of 2007 to 2016, to ask the Council of the CSE to suspend the trading of the company's titles from 31 March 2017 until 30 June 2017.

The Commission has reached this decision since the company, at a recent announcement thereof dated 1 March 2017, states that it has no assets and that it is not possible to continue its operation as a going concern. In addition, the company has failed up to the date of the Commission's decision, to publish its Half-Yearly Financial Report for the period ended 30 June 2016 as a result of which investors are not provided with the required information on its financial situation.

Suspension of Trading of Titles

Flexinvest Plc. On 1st March 2017, following previous announcements dated 29 December 2016 and 13 January 2017, the Cyprus Stock Exchange announced the suspension of trading of the titles of Flexinvest Plc for further two (2) months, i.e. until 2 May 2017, pursuant to Article 185 of the Securities and the Cyprus Stock Exchange Law. This decision was taken to protect investors due to the fact that there has been a material change in the company's financial state following the decision of the Central Bank of the Russian Federation to revoke the banking licence of the credit institution MIP Bank (which forms the company's biggest investment) and appoint a provisional administrator.

Hestiun Properties Plc. On 6th March 2017, the Cyprus Stock Exchange announced the suspension of trading of the titles of «Hestiun Properties Plc» as of Wednesday, 8 March 2017, due to the non submission and publication of the Half-Yearly Financial Report for the period ended 30 November 2016, as required under Article 142 of the Securities and Cyprus Stock Exchange Law.

BROZOS IVY PUBLIC LTD. On 16th March 2017, the Council of the Cyprus Stock Exchange announced the suspension of trading of the securities of BROZOS IVY PUBLIC LTD as of Friday, 17 March 2017.

The decision was taken pursuant to Article 183 and ratified pursuant to Article 184 of the Securities and Cyprus Stock Exchange Law and in accordance with paragraphs 2.3.1.1 and 2.3.1.2(b) of RAA 379/2014 (as amended), since based on recent reports in electronic media it is possible that the value of the security is materially affected, as a result of which the smooth operation of the Market with regard to the said security cannot be ensured or may be threatened.

The suspension will be in effect for a period of up to two months as of 17/3/2017 or until the publication of any information that modifies the current data and which will be assessed accordingly.

Listing of Additional Titles

C.O. Cyprus Opportunity Energy Public Company Ltd. On 1st March 2017, the Council of the Cyprus Stock Exchange announced that it has accepted the listing on the Cyprus Stock Exchange of 20.720.000 ordinary shares in "C.O. Cyprus Opportunity Energy Public Company Ltd" issued as a result of an issue of the capital's share capital at a price of €0.01 each and alloted through private placement. It is noted that the above shares incorporated in the already listed share capital of the company, which amounted to 54.776.000 shares. The trading of the above shares started on Friday, 3 March 2017.





History

The Cyprus Stock Exchange started operations as a legal entity on March 29 1996, based on the Laws and Regulations concerning the Cyprus Stock Exchange, which were enacted by the House of Representatives, Parliament of the Republic of Cyprus in 1993 and 1995 respectively.

The Cyprus Stock Exchange is an organized securities market through which transactions on listed securities take place, such as government bonds, warrants, stocks or any other securities that are listed on the stock exchange.

The main participants in the market are the Members of the stock exchange (stock brokerage companies), custodians, issuers, as well as investors. The CSE is managed by its Board, which is appointed by the government of the Republic of Cyprus.

The stock exchange offers a complete spectrum of products and services:

- Shares
- Bonds (Corporate Bonds, Government Bonds and Treasury Bills)
- Rights
- Warrants
- Share of Undertakings for Collective Invest- ment in Transferable Securities (UCITS)
