### **Trading Commentary**

The market recorded trading activity in 07 counters, namely, ILLOVO, MPICO, NBM, NBS, NITL, REAL, and TNM during the week ending 31<sup>st</sup> May, 2013. A total of 147,384,527 shares were transacted during the week at a total consideration of MK183,583,740.00 (US\$558,845.09) in 20 deals. The *Malawi All Share Index* inched upwards by 138.55 points to close the week at 6552.53 points due to an increase in the *Domestic Share Index* by 110.60 points from 5020.37 points to 5130.97 points as a result of share price gains in ILLOVO by MK5.50 from MK170.00 to MK175.50, NBM by MK2.00 from MK65.00 to MK67.00, NBS by MK0.12 from MK7.00 to MK7.12 and TNM by MK0.09 from MK1.16 to MK1.25. The *Foreign Share Index* was steady at 1113.58 points.

### **Treasury Bills Primary Market**

At the auction held on 28<sup>th</sup> May, 2013, the average yield on the **91 days T-Bill**, the **182 days T-Bill** and the **364 days T-Bill** increased by **1.40%** from **31.98%** to **33.38%**, **2.83%** from **32.23%** to **35.06%** and **1.76%** from **35.87%** to **37.63%** respectively, resulting in **MK5,000.01** million being raised against an announced amount of **MK5,000.00** million. T-bills are open to foreign investors and both the capital and interest are remittal after deduction of withholding tax on interest currently at 15.0%. (*Source RBM*).

Treasury Bills maturities during the week ended 31<sup>st</sup> May, 2013 amounted to **MK2,420.00** million. Maturities for the week ending 07<sup>th</sup> June, 2013 stand at **MK1,329.00** million (*Source RBM*).
