Trading Commentary

The market recorded trading activity in 9 counters, namely, BHL, FMB, ILLOVO, MPICO, NBS, NICO, PCL, SUNBIRD and TNM during the week ending 22nd April, 2016. A total of 960,866 shares were transacted during the week at a total consideration of MK8, 856,393.20(US\$12,978.02) in 29 deals.

In the review period, the *Malawi All Share Index* went down by 68.64 points from 12906.65 points to 12838.01 points due to a decrease in the *Domestic Share Index* by 54.60 points from 10145.75 points to 10091.15 points arising from share price losses in MPICO by MK1.00 from MK7.00 to MK6.00, NBS by MK3.00 from MK18.00 to MK15.00 and NICO by MK0.50 from MK24.00 to MK23.50. BHL had a share price gain by MK3.10 from MK9.80 to MK12.90 and SUNBIRD by MK2.00 from MK30.00 to MK32.00. The *Foreign Share Index* was steady at 1762.13 points.
