## **Trading Commentary**

The market recorded trading activity in 12 counters, namely, ILLOVO, MPICO, NBM, NBS, NICO, NITL, PCL, REAL, STANDARDBANK, SUNBIRD, TNM and OML during the week ending 13<sup>th</sup> June, 2014. A total of 2,734,495 shares were transacted during the week at a total consideration of MK58,233,124.20 (US\$146,959.32) in 37 deals. The *Malawi All Share Index* inched upwards by 3.31 points to close the week at 13241.27 points due to an increase in the *Domestic Share Index* by 2.63 points from 10410.79 points to 10413.42 points as a result of a share price gain in NITL by MK1.05 from MK32.00 to MK33.05. The *Foreign Share Index* was steady at 1740.76 points

## **Treasury Bills Primary Market**

At the auction held on 10<sup>th</sup> June, 2014, the average yield on the **91 days T-Bills** and the **182 days T-Bills** increased by **0.28%** from **20.62%** to **20.90%** and by **0.19%** from **26.17%** to **26.36%** respectively, whilst the **364 days T-Bills** decreased by **0.02%** from **26.59%** to **26.57%**.

T-bills are open to foreign investors and both the capital and interest are remittal after deduction of withholding tax on interest currently at 15.0%. (Source RBM).
