Trading Commentary

The market recorded trading activity in 8 counters, namely, BHL, BRITAM, FMB, MPICO, NBM, STANDARD, TNM and OML during the week ending 24th March, 2016. A total of 340,697 shares were transacted during the week at a total consideration of MK15, 028,485.60(US\$21, 913.96) in 16 deals.

In the review period, the *Malawi All Share Index* went down by 21.87 points from 13493.53 points to 13471.65 points due to a decrease in the *Domestic Share Index* by 17.40 points from 10612.56 points to 10595.16 points arising from a share price loss in FMB by MK4.00 from MK10.00 to MK9.60. The *Foreign Share Index* was steady at 1762.13 points.
