

### MARKET REPORT FOR JUNE 25TH, 2021

#### PRODUCTS

#### <u>EQUITY</u>


A total turnover of 1.006 billion shares worth N10.330 billion in 17,165 deals were traded this week by investors on the floor of the Exchange, in contrast to a total of 981.147 million shares valued at N10.384 billion that exchanged hands last week in 15,001 deals.

The Financial Services Industry (measured by volume) led the activity chart with 646.404 million shares valued at N5.199 billion traded in 8,996 deals; thus contributing 64.26% and 50.33% to the total equity turnover volume and value respectively. The Consumer Goods Industry followed with 108.587 million shares worth N2.257 billion in 3,213 deals. The third place was Conglomerates Industry, with a turnover of 80.257 million shares worth N179.134 million in 614 deals.

Trading in the top three equities namely Zenith Bank Plc, Transcorp Hotels Plc and Access Bank Plc (measured by volume) accounted for 207.341 million shares worth N2.510 billion in 2,774 deals, contributing 20.61% and 24.30% to the total equity turnover volume and value respectively.

The NSE All-Share Index and Market Capitalization depreciated by 2.56% to close the week at 37,658.26 and N19.627 trillion respectively.


Similarly, all other indices finished lower with the exception of NSE CG, NSE Banking, NSE Pension, NSE-AFR Bank Value, NSE AFR Div Yield, NSE MERI Growth, NSE Consumer Goods, NSE Oil/Gas and NSE Sovereign Bond which appreciated by 0.37%, 0.92%, 0.02%, 1.40%, 1.71%, 0.75%, 0.57%, 0.12%, and 0.26% respectively, while the NSE Growth Index closed flat. ### • <u>DELISTING OF GUARANTY TRUST BANK PLC AND LISTING OF GUARANTY TRUST HOLDING</u> <u>COMPANY PLC</u>

We refer to our market bulletin with reference number NGX REG/LRD/MB16/21/06/18 dated 18 June 2021 wherein the Market was notified that trading in the shares of Guaranty Trust Bank Plc (GTB) was placed on full suspension effective Friday, 18 June 2021, in preparation for the delisting of GTB and listing of the Holding Company, Guaranty Trust Holding Company Plc (GT HoldCo).

The Market is hereby notified that the entire 29,431,179,224 issued shares of GTB were delisted from the Daily Official List of the Nigerian Exchange Limited (NGX) today, 24 June 2021 while GT Holdco's entire issued share capital of 29,431,179,224 ordinary shares of 50 Kobo each were also today, 24 June 2021 listed on the Daily Official List of NGX at N28.55 per share.

The delisting of GTB and listing of GT HoldCo on NGX is pursuant to the Scheme of Arrangement between Guaranty Trust Bank Plc and the holders of its fully paid ordinary shares of 50 Kobo each as approved by the Securities and Exchange Commission and sanctioned by the Court.
