

## STOCK MARKET REPORT FOR FEBRUARY 2ND 2019

#### PRODUCTS

#### **EQUITY**


A total turnover of 1.452 billion shares worth N14.788 billion in 19,318 deals were traded this week by investors on the floor of the Exchange in contrast to a total of 1.807 billion shares valued at N17.232 billion that exchanged hands last week in 18,332 deals.

The Financial Services Industry (measured by volume) led the activity chart with 1.204 billion shares valued at N10.500 billion traded in 12,671 deals; thus contributing 82.95% and 71.00% to the total equity turnover volume and value respectively. The Conglomerates Industry followed with 93.206 million shares worth N138.014 million in 916 deals. The third place was Consumer Goods Industry with a turnover of 71.404 million shares worth N3.170 billion in 2,698 deals.

Trading in the Top Three Equities namely, United Bank for Africa Plc, Zenith Bank Plc and Consolidated Hallmark Insurance Plc (measured by volume) accounted for 447.620 million shares worth N4.453 billion in 3,193 deals, contributing 30.83% and 30.11% to the total equity turnover volume and value respectively.

#### INDEX MOVEMENT


The NSE All-Share Index and Market Capitalization depreciated by 2.51% to close the week at 30,636.36 and N11.424 trillion respectively.

# Fidson Healthcare Plc: Revised Terms of Rights Issue - 750,000,000 Ordinary Shares of N0.50 kobo each at N4.00 per Share, on the Basis of 1 new Ordinary Share for every 2 Ordinary Shares

Further to the Market Bulletin with Reference Number: NSE/RD/LRD/MB2/18/07/05, dated 5 July 2018 on the above subject matter, Dealing Members are hereby notified that Fidson Healthcare Plc (the Company) has obtained the approval of the Securities and Exchange Commission (SEC) to issue a revised Rights Circular with respect to its Rights Issue.
