

#### **MARKET REPORT FOR APRIL 14TH, 2022**

#### **PRODUCTS**

The market opened for four trading days this week as the Federal Government of Nigeria declared Friday 15th April 2022 (Good Friday) and Monday 18th April 2022 (Easter Monday) public holidays to commemorate the 2022 Easter celebrations.


Meanwhile, a total turnover of 1.247 billion shares worth N22.372 billion in 23,406 deals was traded this week by investors on the floor of the Exchange, in contrast to a total of 1.137 billion shares valued at N10.812 billion that exchanged hands last week in 23,471 deals.

The Financial Services Industry (measured by volume) led the activity chart with 975.776 million shares valued at N10.678 billion traded in 13,097 deals; thus contributing 78.24% and 47.73% to the total equity turnover volume and value respectively. The Consumer Goods Industry followed with 65.187 million shares worth N1.752 billion in 2,725 deals. The third place was The Services Industry, with a turnover of 42.614 million shares worth 135.745 million in 1.172 deals.

Trading in the top three equities namely Guaranty Trust Holding Company Plc, Zenith Bank Plc and Fidelity Bank Plc (measured by volume) accounted for 429.657 million shares worth N7.786 billion in 5,871 deals, contributing 34.45% and 34.80% to the total equity turnover volume and value respectively.
