

STOCK MARKET REPORT FOR AUGUST 19TH, 2016


A turnover of 1.375 billion shares worth N12.940 billion in 16,915 deals were traded this week by investors on the floor of the Exchange in contrast to a total of 1.361 billion shares valued at N10.711 billion that exchanged hands last week in 16,070 deals.

The Financial Services Industry (measured by volume) led the activity chart with 1.195 billion shares valued at N8.631 billion traded in 10,365 deals; thus contributing 86.90% and 66.70% to the total equity turnover volume and value respectively. The Conglomerates Industry followed with 76.489 million shares worth N154.736 million in 964 deals. The third place was occupied by the Consumer Goods Industry with a turnover of 38.048 million shares worth N1.768 billion in 2,676 deals.

Trading in the Top Three Equities namely – United Bank for Africa Plc, Access Bank Plc and FBN Holdings Plc (measured by volume) accounted for 559.065 million shares worth N2.452 billion in 3,690 deals, contributing 40.66% and 18.95% to the total equity turnover volume and value respectively.

The NSE All-Share Index and Market Capitalization appreciated by 1.48% to close the week at 27,650.32 and N9.496 trillion respectively.


