



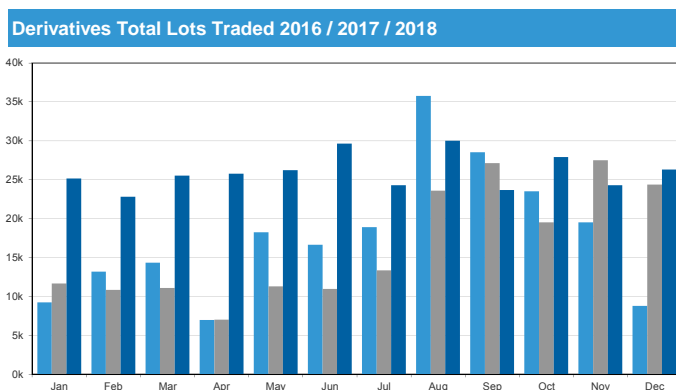
## NZX Limited - Full Year Shareholder Metrics FY 2017
