NZX Annual Meeting poll results

NZX wishes to advise the outcome of resolutions put to shareholders at its Annual Meeting in Wellington today.

Shareholders were asked to vote on five resolutions, four of which were supported by the Board. All resolutions were decided by poll.

Resolutions passed by shareholders were:

- **Resolution 1** that the Board be authorised to determine the auditor's fees and expenses for the 2017 financial year
- **Resolution 2** to elect Frank Aldridge as a Director of NZX Limited
- **Resolution 3** to elect Richard Bodman as a Director of NZX Limited
- **Resolution 4** to re-elect Patrick Strange as a Director of NZX Limited

Resolution not passed by shareholders:

• **Resolution 5** – to elect Tony Falkenstein as a Director of NZX Limited

NZX Chairman James Miller commented: "I would like to thank Tony for the observations he has made about NZX over recent months, which demonstrate a clear enthusiasm for New Zealand's capital markets and our smallest listed companies. These observations have not gone unnoticed and will be considered as part of NZX's strategic review."

"I want to also thank all NZX shareholders who have shared their ideas with me over recent months. We have received a clear message with today's votes, with shareholders expressing confidence in the organisation's leadership and direction, and it is now time for Mark Peterson and the executive team to lead NZX forward."
