RTS Stock Market trading results: June 2011

In June 2011 the RTS Index went up by 0.96% to 1,906.71 points as of June 30, 2011 against 1,888.60 points as of May 31, 2011. Most of the positive impact on the RTS Index dynamics came from rising prices for ordinary shares of Sberbank (SBERS) (up 7.00 points) followed by "OJSC "MMC "NORILSK NICKEL" (GMKNS) (up 6.73 points) and Tatneft (TATNS) (up 4.34 points).

The RTS Standard Index, the blue chips index, rose by 0.71% to reach 11,361.49 points (11,281.21 points as of May 31, 2011). The "second-tier" stock index – RTS-2 Index went up by 1.93% to reach 2,206.14 points (2,164.27 points as of May 31, 2011).

June's growth on the stock market was accompanied by a decrease in volatility levels, shown by the 5.60% fall in the Russian Volatility Index RTSVX, reaching 22.76 points (24.11 points as of May 31, 2011).

Key economy sectors represented on the Russian stock market showed multi-directional movements. The largest gain was demonstrated by the power and metallurgy sectors, with the RTS Electric Utilities Index and RTS Metals & Mining Index growing by 3.20% and 2.53% respectively. The largest decline was reported by the finance industry, with the RTS Finances Index shedding 1.47%.

The regional index, RTS Siberia Index, lost 0.82%.

In June, the US dollar appreciated by 0.03% against the Russian ruble to reach 28.08 rubles per US dollar (28.07 rubles as of May 31, 2011).

In June 2011, the securities trading volume on RTS equaled a value of USD45.06 billion (1,261.27 billion rubles*), including all types of trades. The trading volume on RTS Standard totaled USD9,972.84 million in value.

The top sellers of the month on the RTS Stock Market were Sberbank ordinary shares (SBER) with a turnover of USD4,478.92 million followed by Gazprom ordinary shares (GAZP) with a turnover of USD2,485.09 million and OAO "LUKOIL" ordinary shares (LKOH) with a turnover of USD837.66 million. The shares of the above securities in terms of turnover made up 44.44%, 24.66% and 8.31% respectively.

The top gainers of the month were ordinary shares of OJSC Concern "KALINA" (KLNA) that experienced a growth of 26.58% to reach USD50.00, JSC "Polymetal" (PMTL) that went up by 26.44% to reach USD22.00 and JSC "MOESK" (MSRS) that gained 21.41% to end up at USD0.06 per share.

The top losers of the month were ordinary shares of JSC "Quadra - Power Generation" (TGKD) that lost 32.50% to reach USD0.00027, MASHINOSTROITELNY ZAVOD (MASZ) that went down by 27.27% to reach USD160.00 and "IDGC of Centre, JSC" (MRKC) that decreased by 25.00% to USD0.03.

FORTS Trading Results: June 2011

For the period from June 1 – June 30, 2011, trading volume on FORTS (Futures & Options on RTS) totaled 4,926.53 billion rubles or 86.86 million contracts, including 673.12 billion rubles during the evening trading session. At the end of June 2011, the total open interest stood at 323.13 billion rubles or 6.61 million contracts.

In June 2011, trading volume of the cash-settled futures contract on gasoil (summer grade) launched jointly between RTS Group and Saint Petersburg Exchange reached a value of RUB560.13 million or 24.55 thousand contracts and the trading volume of the futures contract on wheat amounted to RUB455.83 million in value or 62.92 thousand contracts. The trading volume of the power futures contract launched by RTS Group and OJSC Moscow Energy Exchange reached RUB370.35 million or 10.44 contracts.
