

Market News

CSRC Reaffirmed Connecting of Shenzhen, HK Stock Exchanges

The spokesman of CSRC reaffirmed on 12 August that the Shenzhen-HK Stock Connect will be launched at a proper time this year as the regulatory rules and technological preparations are completed. A special work group has been established within CSRC to guide and coordinate policymaking and technical operating issues, and supervisors and exchanges are in close cooperation. The program is expected to expand overseas investors' exposure to China's onshore stock market.

Dazhi Technology (300530)

Guangdong Dazhi Environmental Protection Technology landed on ChiNext Market on 9 August. The company principally engages in research and development, production and sales of new and environmentally friendly chemical products for surface engineering. In 2015, its operating income reached RMB 122 million with a net profit of RMB 38 million.

Urovo (300531)

Shenzhen Urovo Technology landed on ChiNext Market on 9 August. The company principally engages in providing solution for industrial mobile hardware and software integration. In 2015, its operating income reached RMB 273 million with a net profit of RMB 59 million.

Dowell (300535)

Sichuan Dowell Science and Technology landed on ChiNext Market on 12 August. The company principally engages in research and development, production and marketing of leather chemicals. In 2015, its operating income reached RMB 275 million with a net profit of RMB 48 million.

Suzhou Goldengreen (002808)

Suzhou Goldengreen Technologies landed on SME Board on 12 August. The company principally engages in research and development, manufacturing and sales of organic photo-conductor drums. In 2015, its operating income reached RMB 227 million with a net profit of RMB 42 million.

World Bank to Issue SDR Bonds in China

The PBOC had allowed a division of the World Bank to issue bonds denominated in special drawing rights (SDR) in China's interbank bond market, with issuance size of 2 billion SDRs (USD 2.8 billion). Chinese yuan will be the settlement currency. Interbank debt denominated in SDRs will diversify investment portfolios both in China and abroad. Industrial and Commercial Bank of China (ICBC) will be the lead underwriter for the issue.

China Set R&D Targets for 2020

The State Council plan, published on 8 August, lists targets for science and technology from 2016 to 2020 as well as government action to help realize the targets. Priorities for the government over the next five years include directing resources to strategic areas, fostering creativity, creating a favorable policy environment and removing barriers to innovation. China will spend more resources in research areas key to its national strength and security.
