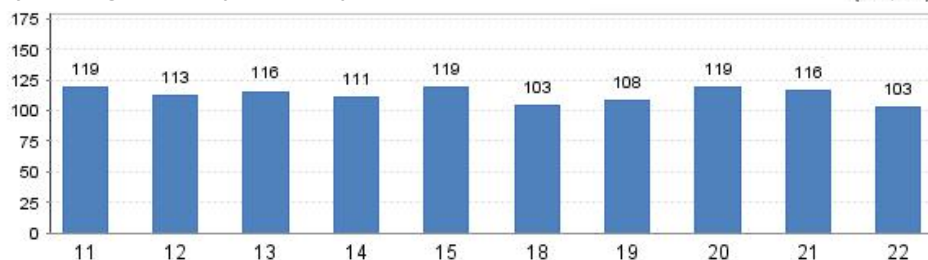

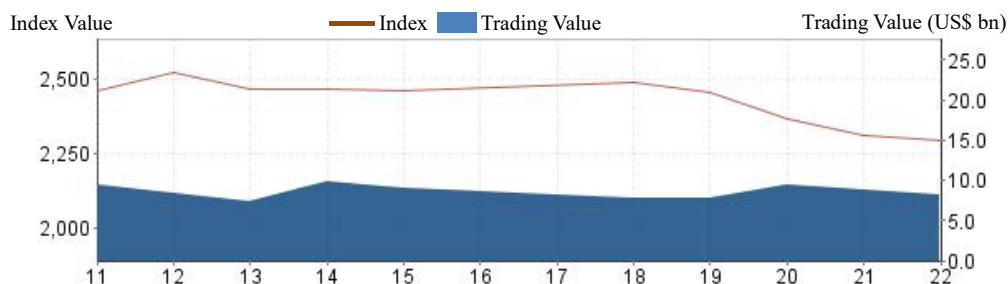

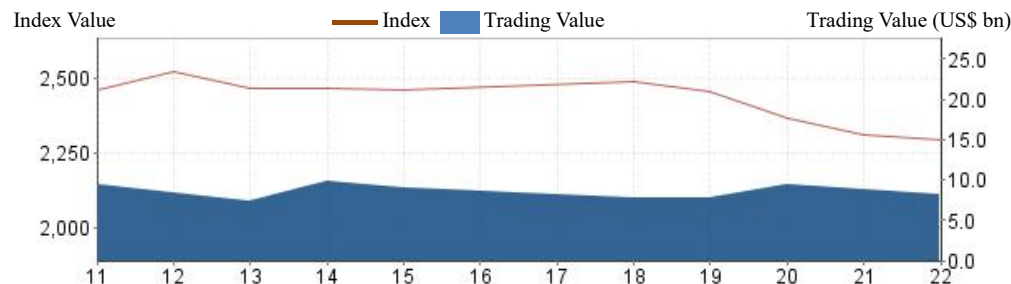
## SZSE Component Index (April 11 – April 22)
