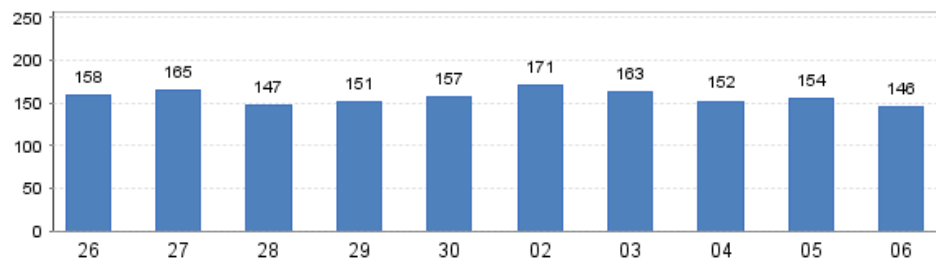

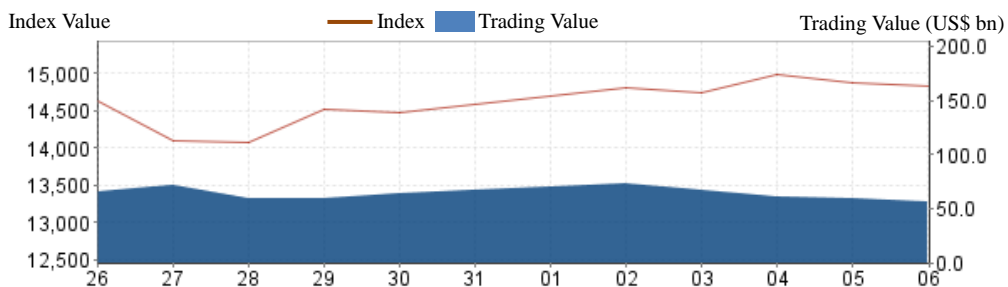

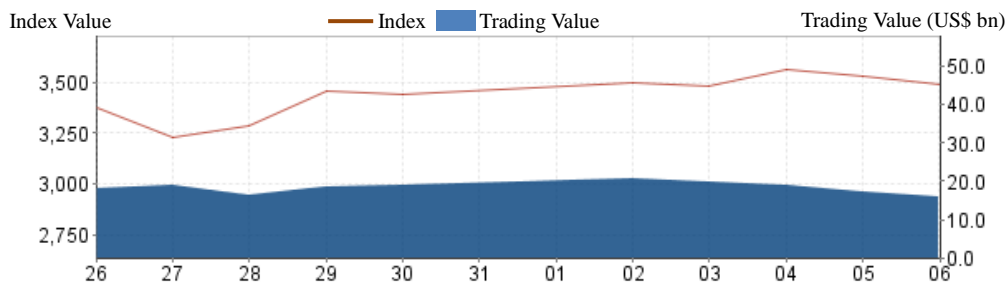

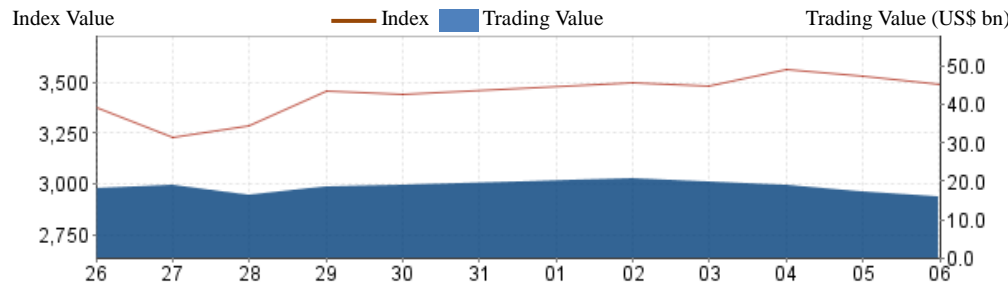
SZSE Component Index (July 26 – August 06)
