(TSX:CLC) will be removed from the S&P/TSX Composite Index, as previously announced, at the same time as the effective date of this review. The company will also be removed from the S&P/TSX Capped Composite, Composite Equal Weight, Completion, Capped Health Care, SmallCap, Equity Income and Composite Dividend indices.
