## December Statistics report from the NASDAQ OMX Nordic Exchanges

### Share Trading

The value of average daily share trading amounted to EUR 1.9 billion, as compared to EUR 2.6 billion during the past 12-month period. The average number of trades per business day was 348,405 as compared to 370,503 during the past 12-month period. The total market cap of listed companies at NASDAQ OMX Nordic Exchange amounted to EUR 657 billion, compared to EUR 822 billion in December 2010.

All figures in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK and Other in EUR). Average per trading day. All exchanges had 21 trading days, except for Helsinki where there was 20.
