



## I. News and Events

- **TAIFEX Reported Steady Volume Increase in May**

Taiwan Futures Exchange (TAIFEX) reported a total volume of 28,470,405 contracts with an average daily volume (ADV) of 1,294,109 contracts traded in May 2023, an increase of 11.30% in monthly ADV as compared to April. ADV of TAIEX Options (TXO), Single Stock Futures (STF) and TAIEX Futures (TX) grew 20.64% to 748,914 contracts, 3.97% to 174,697 contracts, and 0.55% to 129,542 contracts over the previous month, respectively, while that of Mini-TAIEX Futures (MTX) showed a slight decrease of 2.68% to 221,887 contracts. For the night trading session, the overall ADV traded overnight also rose 23.07% over April and accounted for 29.41% of the market's total volume.

- **Dynamic Price Banding Mechanism Applied to Gold Options**

The Exchange started to implement Dynamic Price Banding Mechanism (DPBM) in stages starting from 2018 to enhance price stability. The mechanism currently covers all futures products, as well as index and ETF options. On June 5, 2023, TAIFEX expanded the application of the mechanism to include Gold Options, further broadening the range of DPBM-applicable products to commodity options. - **TAIFEX Implemented Cancel on Disconnect to Proprietary Traders**

TAIFEX recently expanded its Kill Switch functionality to encompass futures brokers in addition to futures proprietary traders, effective from March 20. As part of the Exchange's ongoing efforts to protect market participants and enhance security, TAIFEX further introduced Cancel on Disconnect (COD) service to mitigate transaction risks due to accidental disconnections, starting June 5, 2023. During the initial phase, COD is only available to futures proprietary traders. FCMs wishing to enable the COD functionality shall comply with relevant provisions and obtain TAIFEX's prior approval.
