- **TAIFEX to Expand the Central Clearing Service for OTC Derivatives**

TAIFEX is expanding its central clearing service for OTC derivatives to USD/TWD Non-Deliverable Forwards (NDFs). Launched in July 2022, the service incorporated voluntary central clearing services of TWD Interest Rate Swaps (IRSs) for inter-bank dealers in the first phase. The addition of USD/TWD NDFs to the service will meet the evolving needs of market participants. For a comprehensive clearing specification of USD/TWD NDFs, please visit [here](#).

Furthermore, TAIFEX has amended its rules to allow end customers of clearing members to participate in the central clearing for OTC derivatives. The implementation date of these amendments will be announced in due course.

- **New Single Stock Futures Added**

On May 4, TAIFEX listed ten new Single Stock Futures (SSFs), including seven standard contracts on Ta Ya Electric Wire & Cable (1609), Gold Circuit Electronics (2368), TSEC (6443), Momo.Com (8454), Oneness Biotech (4743), Lanner Electronics (6245), and POYA International (5904), and three mini contracts, which are 1/20 the size of standard contracts, on Momo.Com (8454), POYA International (5904), and eMemory Technology (3529). With these new additions, TAIFEX now offers a total of 257 SSFs (including 24 Mini SSFs and ten ETF Futures) and 48 Single Stock Options (including six ETF Options).
