TAIFEX Saw Strong Growth for the First Two Months

Taiwan Futures Exchange (TAIFEX) reported its total trading volume of 22,681,067 contracts in February. For the first two months of 2021, the average daily volume (ADV) reached 1,862,216 contracts, up 33.64% from 2020. TAIFEX flagship products—Mini-TAIEX Futures (MTX), TAIEX Futures (TX), and TAIEX Options (TXO) continued their growth momentum, as ADV hit 340,142 contracts, 233,745 contracts, and 1,026,432 contracts, respectively, posting growth of 38.77%, 23.62%, and 24.66% from 2020. Due to increased volatility in the cash market, TAIFEX has also seen ADV growth for its Single Stock Futures, up 126.11% from 2020, to 238,450 contracts. Attributed to surged international freight rates and positive industry outlook, contracts on Evergreen Marine Corp. (Taiwan) Ltd. (CZF) posted the strongest performance of all 218 Single Stock Futures, with ADV reached 48,650 contracts during the same period.

Change of Trading Hours for US and UK Products Due to Daylight Saving Time

As the US Daylight Saving Time starts from Sunday, March 14, 2021, the trading hours on the last trading day for the expiring contracts of US equity index futures, i.e., S&P 500 Futures (SPF), DJIA Futures (UDF), and Nasdaq-100 Futures (UNF) will end at 9:30 P.M. Taipei Time. Similarly, the expiry contracts of Brent Crude Oil Futures (BRF) will close at 2:30 A.M. Taipei Time. The affected expiry month include 202103, 202106 and 202109 contracts for SPF, UDF and UNF, and 202105 to 202112 contracts for BRF. Also, as the British Summer Time starts from Sunday, March 28, 2021, the trading hours on the last trading day for FTSE® 100 Futures (F1F) expiring contracts, with expiry month from June to September 2021, will end at 5:15 P.M. Taipei Time.

Market to be Closed for Children's Day and Tomb Sweeping Day

In observance of Children's Day and Tomb Sweeping Day, TAIFEX will be closed for trading on Friday, April 2 and Monday, April 5, respectively.
